

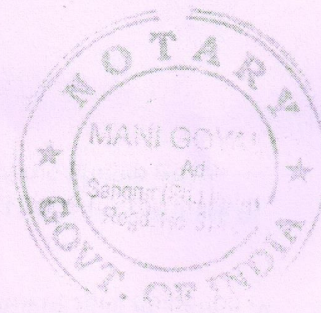

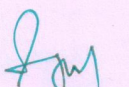

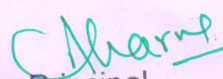

After careful consideration of the documents and the recommendations of DEO (Sen. Sec.) and the DPI (Sen. Sec.) Punjab, Chandigarh, the Punjab Govt. is issuing the required No Objection Certificate subject to the following terms and conditions:

If in future it comes to the notice that you have submitted wrong information to the Govt. when applying for No Objection Certificate and that you have not been obeying instructions issued from time to time by Punjab Govt. and that as much conditions laid down in the affidavit are not being met, the NO Objection Certificate can be revoked and with drawn at anytime.

That teaching of Punjabi upto matric level will be compulsory in your school and the CBSE New Delhi must take arrangement to conduct examination in the subject of Punjabi in such schools. It is stated that if this is not done, the No Objection Certificate will be withdrawn.

The school management shall implement in to the notifications issued by the Punjab Govt. under RET Act 2009 and it shall strictly follow the rules framed under RET 2009 for the State of Punjab.

After getting the school affiliated to CBSE New Delhi, the school management shall be bound to pay the salaries and the allowances of the teaching and non teaching staff of the school through account payee cheques as is done in case of Govt. employees. In case the school management fails to do so, the No Objection Certificate shall be withdrawn.

You personally and your management shall make it certain that whenever any information is sought by the DEO of your district or by any other higher authority of the Education Department, it shall be made available to them and they shall be given co-operation required.

The original file is being returned to Aadhar Public School, Village Badrukhan, District Sangrur.

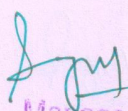

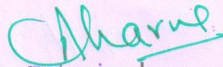
